- 3) A one-page statement written by the student of his/her professional aspirations.
- 4) A notarized copy of the student's parent(s) federal tax return for the year 2007. The first two pages summarizing the return and signed by the taxpayer are sufficient. Additional schedules and verifying information are not required. All information will be kept confidential.

The application and all supporting documents must be postmarked no later than April 18, 2008. Incomplete applications and those postmarked after the deadline will not be considered.

The names of the scholarship winners will be announced at the RTC Spring Luncheon.
